Shower is designed to be installed into a finished wall from the front. When installed properly and in accordance with all other Shower Stall Type requirements, unit will conform with 2010 ADA Standards and 2019 California Access Compliance Reference Manual with DSA Access Compliance Code Cycle Supplement, Effective July 1, 2021. Refer to applicable Accessibility Guidelines for complete details.

**Fixed Upper Conical Showerhead** Model WHCSH is WaterSense Certified with 1.5 GPM flow rate and is chrome plated brass to provide vandal and ligature resistance. Spray pattern is a non-adjustable multi-stream style.

**Ligature Resistant Handheld Shower** is provided. Model WHCHS includes Pushbutton for On/Off control with Non-positive Shutoff, 1.5 GPM Flow Control, 60" long Stainless Steel Hose. Hose assembly is removable and includes a Ligature Resistant Collapsible Mounting Bracket.

**Temperature / Pressure Balancing Mixing Valve** is IAPMO Certified and delivers blended water to meet performance requirements of ASSE 1016-2011. Control Handle is patented Tri-lever Ligature Resistant design. Valve conforms with lead free requirements of NSF61, Section 9, 1997 and CHSC 116875. Refer to WHSV16 series submittal for additional Data.

Provide Diverter Valve and ASSE 1016 Compliant Temperature/Pressure Balance Mixing Valve. Both Controls shall be provided with Chrome Plated, Patented ADA Compliant Ligature Resistant Tri-Lever Handles. Fixture shall be furnished with necessary fasteners for proper installation.

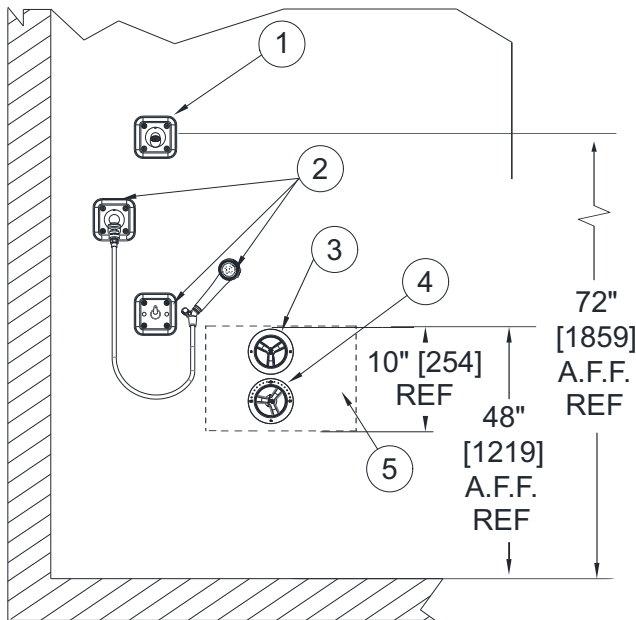

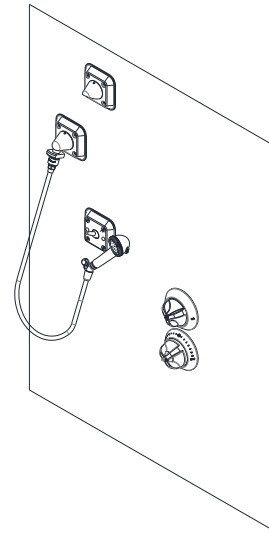

Front View

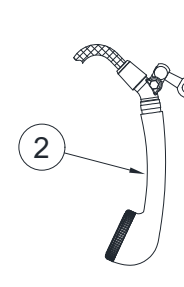


Isometric View
