**Ligature Resistant Handheld Shower and Collapsible Handheld Shower Mounting Bracket**

Ligature Resistant Adapter Base with Handheld Shower includes a 60" Flexible Stainless Steel Hose, Expansion Plug Quick-Disconnect, Handheld Shower and a Collapsible Handheld Shower Mounting Bracket. Used for ADA applications where a Handheld Shower is required. The Handheld Shower can be used as needed but when removed from Shower area, the Adapter Base and Collapsible Shower Mounting Bracket are Ligature Resistant.

(Note: For maximum ligature resistance a fixed Conical Shower Head is recommended. Verify local requirements to ensure ADA compliance.)

**IMPORTANT:** This item is not sold as a "break away Hose." The WHCHS is a Quick-Disconnect design (only), used for removal of the Handheld Shower however, without a ligature point remaining on the Socket end after removal. The Handheld Shower Mounting Bracket includes an Auto-release hook with an adjustable release range of 0 to 25 lbs. The release point is factory set to release at 10 lbs. +/- 2 lbs. at the base of the hook.
